Policy Memorandum

Purpose: This Policy Memorandum (PM) provides guidance on processing fee waiver requests received

Scope: Unless specifically exempted herein, this PM applies to and is binding on all the students admitted in Vishnu Waman Thakur Charitable Trust's.

Authority: This PM is issued under the authority of the Management Committee of Vishnu Waman Thakur Charitable Trust's.

Policy: Under this policy, the students may apply for and be granted fee waiver for certain benefits based on inability to pay. Eligibility for fee waiver will be at the discretion of appropriate committee.

Implementation:

The needy students are supposed to submit fee-waiver requests in the form of a written application. The application is intended to bring clarity and consistency to the fee-waiver process.

In general, fee-waiver requests will be reviewed by considering, in a step-wise way, whether the applicant is receiving a means-tested benefit, whether the applicant's household income level renders him or her inability to pay, or whether recent financial hardship prevent him or her to pay. This PM also provides example of required or acceptable supporting documentation.

Waiver of Fees Process:

- (a) Submission of Request
- (b) Review of Request.
- (c) Processing Fee Waiver Request

Use: This PM is intended solely for needy students of VIVA College of Arts, Commerce and Science. It is not intended to, does not, and may not be relied upon to create any right or benefit, substantive or procedural, enforceable by law or by any individual or other party in removal proceedings, or in any other form or manner.
